
- The Chartered Institute of Logistics and Transport (CILT) is an organization that offers significant benefits to all its members, as well as a complete suite of educational courses internationally.

CILT Membership Designations

Something for everybody – from students building careers to those who have already accomplished much in the profession.

- Individuals achieve globally recognised qualifications on completion of each level
- As a professional qualification holder, members may also be eligible to use ‘post-nominal’ letters after their name subject to appropriate experience. Indicative requirements are shown below:

Post Nominal	Description	Indicative Requirements (one of the following)
MILT	Member	<ul style="list-style-type: none">• Relevant level 3 qualification AND three years work experience• CILT Certificate AND at least three years work experience• CILT Diploma AND at least two years work experience
CMILT	Chartered Member	<ul style="list-style-type: none">• An accredited degree AND at least four years experience in the profession (including two years at senior level)• CILT Advanced Diploma AND at least five years in the profession (including two years at senior level)
FCILT	Chartered Fellow	<ul style="list-style-type: none">• This is the highest grade of membership restricted to individuals who can demonstrate that they operating at the top of the profession• Must meet the criteria for Chartered Membership and have at least seven years experience at a high level of management responsibility within the profession

Information on CILT membership, assessments and preparing for exams

- Students are required to be CILT student members before sitting exams.
- We encourage and support all students in registering with CILT International as well as their local CILT branch
- CILT assessments run at prescribed dates during the year, set by the local Harley Reed office. Contact our team for your local timetable
- Whilst students are free to attempt as many papers at one sitting as they wish, it is our recommendation that students attempt a maximum of 2 papers per examination
- Students should be prepared to dedicate up to 50 hours of self study per module when choosing their preferred progression speed

Various pathways are available to Diploma level 5 students through the WBA route.


All individuals will complete 4 modules at Diploma level.
